PROVISIONAL ADMISSION NOTICE FOR FIRST YEAR
B.A., LL.B.(GEN. & HONS.)(SEMESTER – I) FOR THE SESSION 2018-19

As per the direction of Board of Under Graduate Council, University of North of Bengal it is notified that the provisionally selected candidates for the provisional admission in First year of B.A., LL.B.(Gen. & Hons.)(1st Semester) classes of 5 year integrated Law Course for the session 2018-2019 should bring all necessary original documents such as Madhyamik / ICSE / CBSE i.e. class 10th Admit Card as age proof certificate, Mark Sheet of Higher Secondary (10+2) or equivalent examination, S.C./S.T./ OBC– A /OBC- B/PH (if applicable) certificates in the name of the Candidate etc. along with 2 sets of attested photocopies both side of all documents and 2 passport size recent photographs during office hours for verification and taking provisional admission as per the schedule given below. If the College Office is satisfied in all points the candidate will be asked to deposit of Rs.10, 545/- (Rupees ten thousand five hundred forty five only) (including University Registration Fee Rs.250/-) for B.A., LL.B.(Gen.) Course and Rs.15,250/- (Rupees fifteen thousand two hundred fifty only) (including University Registration Fee Rs.250/-) for B.A., LL.B.(Hons.) Course with the College S.B. A/c. No.528602010022224 lying with the Union Bank of India, Jalpaiguri Branch, Jalpaiguri.

After depositing the above amount with the said Bank the candidate will obtain a receipt from the College Office on submission of the Bank receipt within the stipulated period (mentioned in the schedule below) and then the candidate will be treated a "Provisionally Admitted Student".

The selected Candidates seeking admission is requested to fill up the 'Anti Ragging Undertakings(Affidavits)' form in the website of www.antiragging.in or www.amanmovement.org2009 and after filling the form submit the hard copy of the Anti Ragging Undertakings(Affidavits) duly signed by Candidate and Father/Mother/Guardian to the college office at the time of admission.

The provisionally selected candidate according to approved merit list should take provisional admission within the stipulated period mentioned below in the schedule of provisional admission otherwise the claim for provisional admission will be forfeited.

Candidates who have already admitted in other institution and having registration number of the University must produce original registration certificate along with the release certificate from the College Authority where he/she is studying at the time of admission and no further date will be given for the same.
