**MASTER OF LAWS(LL.M.) (SEMESTER – I ) FOR THE SESSION 2022-23**

It is notified that the provisionally selected candidates for the provisional admission in First year of Master of Laws(LL.M.) (1<sup>st</sup> Semester) classes of 2 year Course for the session 2022-2023 should deposit through online mode through, our college website i.e. [www.jalpaigurilawcollege.in](http://www.jalpaigurilawcollege.in) of Rs.10, 000/-(Rupees ten thousand only)(excluding University Registration Fees, if any).

After depositing the amount online, the candidate has to send a scan copy of the online deposited/transaction receipt to our college email id: [jallawcollege@rediffmail.com](mailto:jallawcollege@rediffmail.com) on the date of deposit.

The candidates who have taken admission are advised to bring all necessary original documents such as Madhyamik / ICSE / CBSE i.e. class 10<sup>th</sup> Admit Card as age proof certificate, Mark Sheet of LL.B. examination, S.C./S.T./ OBC– A /OBC- B/PH (if applicable) certificates in the name of the Candidate etc. along with 2 sets of attested photocopies both side of all documents and 2 passport size recent photographs during office hours for verification on the date of Commencement of Classes (As per the order of Government of West Bengal and University of North Bengal time to time.) and after verification if the College Office is satisfied in all points the candidate will be treated a “**Provisionally Admitted Student**” otherwise his or her admission will be treated as cancelled. The Roll No of Admitted Candidates will be given/posted by the College on the date of Commencement of Classes after proper verification of documents with originals.

*The provisionally selected candidate according to approved merit list should take provisional admission within the stipulated period mentioned below in the schedule of provisional admission otherwise the claim for provisional admission will be forfeited.*


1. DATE OF STARTING OF PROVISIONAL ADMISSION: 22/09/2022




